**Directions to Local Health Boards as to the Statement of
Financial Entitlements (Amendment) (No. 4) Directions 2016**

Made - - - - *16 August 2016*

Coming into force - - *17 August 2016*

The Welsh Ministers in exercise of the powers conferred on them by sections 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006(a), and after consulting in accordance with section 45(4) of that Act with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate give the following Directions:

Title, commencement and application

1.—(1) The title of these Directions is the Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 4) Directions 2016.

(2) These Directions are given to Local Health Boards(b) and apply in relation to Wales.

(3) These Directions come into force on 17 August 2016 but have effect from 1 April 2016.

Amendments to the Statement of Financial Entitlements

2. The Directions to Local Health Boards as to the Statement of Financial Entitlements Directions 2013(c) which came into force on 11 June 2013, as amended by the Directions listed in Annex J at Schedule 1 to these Directions, are further amended as follows.

Amendment of Section 7

3. Section 7 (childhood immunisations) is amended as follows —

(a) in paragraph 7.10 (calculation of quarterly two-year-olds immunisation payments), for “63” in each place where it appears, substitute “65”; and

(b) in paragraph 7.20 (calculation of quarterly five-year-olds immunisation payments), for “64” in each place where it appears, substitute “62”.

Amendment of Section 8

4. In Section 8 (rotavirus vaccine), in paragraph 8.3 (payment for administration of rotavirus vaccine), for “£7.80” substitute “£9.80”.

(a) The National Health Service (Wales) Act 2006 (c.42).

(b) Local Health Boards established pursuant to section 11 of the National Health Service (Wales) Act 2006.

(c) The Directions to Local Health Boards as to the Statement of Financial Entitlements 2013 (2013 No.8) as amended.

Amendment of Section 9

5. Section 9 (pneumococcal vaccine and Hib/MenC booster vaccine) is amended as follows-
- (a) in paragraphs 9.3, 9.6, 9.8, 9.9(b), 9.10, 9.11 and 9.12, for “£15.28” substitute “£19.60”; and
 - (b) in paragraph 9.15, for “£15.10” substitute “£19.60”.

Amendment of Section 10

6. Section 10 (shingles immunisation programme) is amended as follows-
- (a) in paragraph 10.2 (payment for administration of the Shingles vaccine), for “£7.80” substitute “£9.80”; and
 - (b) in paragraph 10.5 (eligibility for payment), for “£7.80” substitute “£9.80”.


