Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darnau perthnasol o Gefnffyrdd yr A487 a'r A40, wedi eu bodloni y dylid cyfyngu ar draffig a/neu ei wahardd ar ddarnau penodedig o'r cefnffyrdd oherwydd gwaith y bwriedir ei wneud ar y ffyrdd neu gerllaw iddynt.

The Welsh Ministers, as traffic authority for the relevant lengths of the A487 and A40 Trunk Roads, are satisfied that traffic on specified lengths of the trunk roads should be restricted and/or prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

### Title, Commencement and Interpretation

### **Cymhwyso**

8. Nid yw’r gwaharddiadau a’r chyfyngiad yn erthyglau 3, 4, 5, 6 a 7 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y mae arwyddion traffig yn eu dangos.

“the trunk roads” (“*y cefnffyrdd*”) means those lengths of the A487 Fishguard to Bangor Trunk Road and A40 London to Fishguard Trunk Road in the County of Pembrokeshire specified in the Schedules to this Order;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 06:00 hours on 11 January 2019 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Prohibitions and Restriction**

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the lengths of the trunk roads specified in Schedule 1 to this Order.

4. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the opposite direction when a one way traffic system is operating on the lengths of the trunk roads specified in Schedule 2 to this Order.

5. No person may, during the works period, ride or cause to be ridden any pedal cycle, to proceed in the opposite direction when a one way traffic system is operating on the lengths of the trunk roads specified in Schedule 2 to this Order.

6. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the lengths of the trunk road specified in Schedule 3 to this Order.

7. No person may, during the works period, except upon the direction or with the permission of a police constable, police community support officer or civil enforcement officer, cause or permit any vehicle to wait at any time on the sides of the lengths of the trunk roads specified in Schedule 3.

### **Application**

8. The prohibitions and restriction in articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as indicated by traffic signs.

#### **Temporary Prohibition of Overtaking and Waiting Restriction**

1. The length of the A40 High Street from the centre of its junction with the new Chimneys Link Road to the centre of its junction with the A487 West Street and High Street.
2. The length of the A487 West Street from the centre of its junction with the A40 High Street and the A487 Main Street to the centre of its junction with the new Chimneys Link Road.
3. The length of the A487 Main Street from the centre of its junction with the A40 High Street and the A487 West Street to a point 70 metres north east of that junction.

#### **THE A487 AND A40 TRUNK ROADS (FISHGUARD, PEMBROKESHIRE) (TEMPORARY TRAFFIC PROHIBITIONS AND RESTRICTIONS) ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A487 and A40 trunk roads at Fishguard in the County of Pembrokeshire.

The effect of the Order will be to temporarily:

- i) prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the lengths of the trunk roads specified in Schedule 1 to this Notice. The alternative routes are also described in that Schedule;
- ii) prohibit all vehicles and cyclists, other than those being used by the emergency services and for the works, from proceeding in the opposite direction when a one way traffic system is operating on the lengths of the trunk roads specified in Schedule 2 to this Notice;
- iii) prohibit all vehicles, with exemption for emergency and works vehicles, from overtaking during convoy working on the lengths of the trunk roads specified in Schedule 3 to this Notice; and
- iv) prohibit all vehicles from waiting during specific times on the lengths of the trunk roads specified in Schedule 3 to this Notice.

It is expected that the prohibitions and restrictions, which will be signed accordingly, will come into
